# BLACK HISTORY MONTH

Massachusetts is known to be rich in colonial history, as seen preserved throughout the state in it's many museums, memorials and the like. Our home has been the birthplace of many beginnings and "firsts" in the country, paving the way to "change the course of history," including that of Black History.

African-Americans have engaged in every war fought by or within the United States. In the North, we are the home of the first African-American regiment, the 54th Massachusetts Infantry.

William Harvey Carney, an African-American, served as a Sergeant in the 54th Massachusetts Infantry. Separated from his regiment during the storming of Fort Wagner, and having endured three acute wounds, he saved the 54th's flag from capture and did not let it touch the ground. In 1900, he was the first African-American awarded the Congressional Medal of Honor, our Nation's highest military award.

Charles Douglass is said to be the first soldier enlisted in African-American regiments from Massachusetts having served in the 54th Infantry and then as a first sergeant in the 5th Cavalry.

<u>Fire and Thunder Massachusetts Blacks in the Civil War</u> at the Commonwealth Museum. They mention it to be "a story worth telling" but it is also a story worth reading.

I would be remiss if I did not mention one of our very own, DAV Department of MA 2nd Junior Vice Commander and current Adjutant and Treasurer of Chapter 64, Andrea Gayle-Bennett who became the first African-American female O-6 in the history of the MA Army National Guard as well as the first non-physician and first African-American to hold that position. These are only a fraction of Andrea's accomplishments during her military service and she continues to serve beyond service in many ways.

February, is Black History Month.

Dedicated to create awareness of the contributions to the United States from African-Americans.

This month, over 30 DAV & DAV Auxiliary members from the Department of Massachusetts will travel to Washington, D.C. to lobby our federal legislators on the importance of supporting <u>DAV's Critical Policy Goals</u>. By enacting new laws supporting our ill & injured veterans, Congress can assist the VA in caring for our fellow veterans, helping us to fulfill the mission of the DAV.

Our goal for this visit is to ensure that Massachusetts Representatives & Senators strongly support our initiatives. Our combined efforts show up in the many veterans-related bills enacted into law by Congress. Examples of these successes are shown in the 2022 Legislative Victories for Veterans report. I am also including a PACT Act Overview for your use. The Promise to Address Comprehensive Toxics (PACT) Act of 2022 is a new law that expands VA health care & benefits for Veterans exposed to burn pits and other toxic substances. This law helps us provide generations of Veterans and their survivors with the care and benefits they've earned and deserve, thanks in part to your efforts.

There is still time to sign-up for DAV Mid-Winter Conference in Washington, D.C. Feb 26- Mar 1, 2023!

Locally, at the Massachusetts State House we will need to be proactive with our Legislative & Executive branches of Government. Currently, the web site for the 193rd General Court of the Commonwealth of Massachusetts states: "there are no members appointed in the current General Court" assigned to the Joint Committee on Veterans and Federal Affairs. Our state government is currently addressing many worthwhile goals & priorities, and DAV Department of Massachusetts must do it's best to ensure that service to our military & veterans remains a top priority.

Also, at the next Department Executive Committee (DEC) Meeting, we will address a method for you to influence our legislative process by preparing a Resolution that will be reviewed by the DAV Department, then the National staff & volunteers at our Annual Meetings. If your proposal gets approved, it could be included by the DAV Legislative Team in next year's edition of DAV's Critical Policy Goals. I am attaching an overview on <a href="Writing a DAV Resolution">Writing a DAV Resolution</a> in preparation for this future training session.

First of all, I hope everyone had a wonderful holiday season and that the New Years finds all of you in good health. Last week there was a Line Officer meeting that highlighted some of the different changes that are coming in the next few months. The main one is that the Department will be sending out a meeting template for Chapters to follow. The purpose of this is to build on some of

the things that the more successful Chapters are doing and to have consistency throughout the State. It's not a requirement, but rather a suggestion as to what may help not only maintain, but build membership.

The Membership Committee met a few days after that and built on the outline of the previous Line Officer meeting. The bottom line was that if our Chapters want to not only survive, but to expand, each organization will have to attract new Veterans. The one thing that was least understood was that virtually any Veteran that discharged with a rating above dishonorable is qualified to join the DAV. Let me reiterate that, any Veteran that has a discharge above Dishonorable is eligible to join the DAV. I always thought that you had to have a disability rating of 10% or more to join. The reason why that isn't true is because you only need to be eligible to apply for a disability rating to join, so that leaves the door wide open to almost any Veteran. How you approach the Veteran is up to you, but a very good suggestion is to ask him or her to meet for coffee at a local restaurant. This way there isn't any pressure, and you can explain what we're all about before asking if they would like to come to a meeting. The details are up to you, but the more we reach out, the better the chances of increasing our membership. This not only helps us, the DAV, but it also helps the Veteran. He or she will better understand what his or her benefits are for having served. The final point you can stress is that by joining they will become a part of the top-rated Service Organization, who's only goal is to help other Veterans.

Most of us are already providing rides to our fellow veterans to medical appointments just to be a good friend. Please consider signing up for the DAV Transportation Network as a volunteer driver so those miles can get logged and credited to the Department! Black Veterans have fought in our military since the Revolutionary War. We are working to improve communication within the Department beginning at the chapter level. As many of you have already seen, we will be compiling and dispersing a monthly order of business template to our chapters. This template is in attempt to ensure we are all sharing the same pertinent information at our chapter meetings, but also to bring us back online past the pandemic to ensure we are following proper meeting rituals, utilizing our line officers and chair people, sharing up to date reports, and recording proper minutes.

This is very much a work in progress, so if you would like to see any changes or have any suggestions please reach out and let us know! We would love to hear your feedback on this initiative!

To view current Bills before the 193rd General Court of the Commonwealth of Massachusetts, please visit https://malegislature.gov/bills and in the search bar on the left type "veteran". We have 75 Bills before the State at this time. While the Department will be reviewing and staying current with all veteran related bills our concentration at this time will be increasing annuities for disabled veterans and gold star families, and tax abatements.

Would you like to see any new laws, or changes made to benefit veterans in the State or Federally?

Please, work with your chapter to write a Resolution! Resolutions will be passed forward to the Department, reviewed, and voted on at Department Convention.



VA Life Insurance policies have been serving our nation's Veterans, service members, and their families for over 100 years. Starting January 1, 2023, enrollment opens for Veterans Affairs Life Insurance (VALife)—a new program offering increased access for Veterans age 80 or under with any level of service-connected disability (0-100%).

Life insurance is a key component for future financial planning. With the right policy and coverage amount, life insurance can cover end-of-life

costs, provide an inheritance to family, serve as income to a spouse, or cover some outstanding debts.

Those currently enrolled in VA's current policy for service-connected Veterans, Service-Disabled Veterans Life Insurance (S-DVI), may keep their coverage or switch to VALife. Although S-DVI will be closed to new enrollments after December 31, 2022

#### Eligibility

All Veterans age 80 and under, who have a VA disability rating of 0 to 100 percent are eligible for the VALife program and have no time limit to apply. Veterans who are 81 or older and have applied for VA Disability Compensation before age 81 but did not receive the rating for a new service-connected condition until after turning 81 are also eligible if they apply within two years of their rating.

#### Type of Coverage

The VALife program offers whole life guaranteed acceptance coverage. Under this type of coverage, the face amount of coverage takes effect two years after the date of enrollment as long as premiums are paid during the two-year period. This two-year waiting period replaces the need for medical underwriting. If the insured dies within this two year period, the beneficiary will receive all premiums paid plus interest.

#### Cost

The premium rate (the amount you will pay each month or annually for your coverage) depends on your age and the amount of coverage you elect. The premiums for VALife are fixed and based on your age when you enroll. Click here to FIND OUT MORE ON PREMIUM COSTS.

#### Can premiums be waived?

There are no premium waivers for the VALife program.

### How to Apply?

VALife will take effect January 1, 2023. The application will become available on VA's website at that time
