This effort has been ongoing since the founding of DAV over 100 years ago. DAV's legislative and policy goals are based directly on resolutions submitted by DAV departments and chapters across the country, with DAV members serving as the driving force behind our organization's advocacy mission. I'll share more of this process with you in upcoming newsletters.

I have organized a Legislative Committee for the upcoming year, and if you are interested in joining us, please send me an email or text to be included. Our goals for the year include the following:

- Ensure a strong attendance at the 2023 DAV Mid-Winter Conference in Washington, D.C.
- Share DAV National Critical Policy Goals with Department membership
- Confirm that all Officers, Committee & senior staff are enrolled in DAV CAN (Commanders Action Network)
- Share information on how to write a resolution, prior to the Department Convention
- Plan to meet & correspond with State Veterans Affairs legislative leaders
- Investigate "Quorum" State-level legislative contact notification program (similar to National CAN Program)
- Update DAV members on progress of veterans-related bills in Congress



On June 7, 2022, five important veteran-related bills were signed by the President and became public law.

- SERVICE Act (P.L. 117-133)
- Veterans Rapid Retraining Assistance Program Restoration and Recovery (P.L. 117-138)
- Making Advances in Mammography and Medical Options for Veterans Act (MAMMO Act) (P.L. 117-135)
- Radiation Exposure Compensation Act (RECA) Extension Act (P.L. 117-139)
- Strengthening Oversight for Veterans Act (P.L. 117-136)

These bills get the attention they deserve because of organizations like ours and individuals that advocate for veterans and their families.

One current bill being proposed is H.R. 7589 the Reduce and Eliminate Mental Health Outpatient Veteran (REMOVE) Copays Act. This legislation would eliminate medical care copayments for veterans' first three mental health visits in a calendar year.

Please contact your representatives and ask them to cosponsor this bill and others DAV supports. Sign up for the Commander Action Network (CAN) and get started today!
