Below is a link to the 2022-2023 Legislative Program document <u>LegislativeProgram_2022-2023.pdf (dav.org)</u>. The first part of this document explains the importance of DAV Resolutions, along with the impact, such as the blue water and the Pact Act, and the process that it takes to get them approved at the DAV National Convention. The rest and majority of the document lists and explains the resolutions for 2022-2023. It's a large document, but will give you the best examples of how to write a resolution. You may even find that what you were thinking of has already been addressed. If it has, that doesn't mean you don't need to write another one. Try looking at it from another angle and see if you can put a different spin on it. More times than not, a resolution fails because of how it was written rather than what it was trying to address.

My other goal for this year is to have as many members, and their family members as possible, signup for the DAV CAN organization, the Commander's Action Network. Anyone can sign up for it at DAV | Sign In (quorum.us). There is no requirement to be either a member of the DAV or a Veteran. Once you sign up, just click on the "Act Now" button. That will bring you to the list of active bills in both the Congress and the Senate. Look through the list, and when you see a bill that you want to support, hit the blue "Write" button on the right-hand side. That will bring up a prewritten letter, signed by you, that will be sent to your specific Congressperson or Senator encouraging him or her to support that bill. Keep in mind that the list I'm referring to now is for 2022-2023. You might want to wait a short time for the 2023-2024 Legislative Program to be released after the 2023 National Convention this August.

3RD JR VICE EUGENE MCGREEVY CONTINUED...

The purpose of the Department Constitution and Bylaw Committee is to review, and recommend any changes to the Department Bylaws. Our recommendations then go before the voting body at Department Convention each June for approval.

As most of you are aware by now, as it was highlighted in our last newsletter, at this past Department Convention (June 2023) the Committee recommended a change to the Bylaws that would remove the current 5-year rule for Chapter Bylaws to be reviewed. My recommendation is that all Chapters have a Bylaws Committee consisting of at least a 3-member team. I will be passing along a base template for Chapter Bylaws to anyone who needs a starting point, and then all you would have to do is add your Chapter specific information.

As it is still a duty of the 3rd Jr Vice Commander to assist Chapters with their Bylaws, I will be reaching out to Chapters across the State by Zoom over the next coming months to ensure that everyone is up to date, and provide any assistance they may need.

August 3-8th will be National Convention in Atlantic City, NJ. Following National Convention our recommended Department Constitution and Bylaw changes shall be in effect. The updated Bylaws will then be made available on our Department website dayma.org inside the members portal, under forms. If you have any questions in the meantime, please do not hesitate to contact me!

DEPARTMENT INSPECTOR DEB OLSON

A hybrid training session for chapter commanders and adjutants was held on July 6th. With 20 of our 47 active chapters in attendance. I was a little disappointed in the turn out. The Department is doing all we can to help chapters with the officers' tedious but necessary duties.



On August 30th, the department will host a hybrid training session for chapter treasurers. We

ask that all treasurers be in attendance and bring with them the necessary documents required to complete their 2022-2023 Annual Financial Report. We will go through the AFR one line at a time and answer your questions so that your reports can be completed accurately. The Treasurer, as noted in your Officer report, will be notified via email with a Zoom link.

The Treasurer and Adjutant are to get all documents required to complete the chapter annual financial report. Start the process now, your reports need to be received no later than September 30th. For chapters with incomes over \$25,000, your AFR (Annual Financial Report) is to be received by National, NLT September 30, the department wants those NLT September 15. We want those reports required to be submitted to National to come to the department for review before submitting them. These reviews are to catch any issues so they can be addressed prior to submittal to National, so plan accordingly.

Chapters should now elect or appoint their Audit committee, which cannot consist of the Commander, Senior Vice, Adjutant, or Treasurer, as your AFR will need to be reviewed and signed prior to submittal. Your chapter's 990n is also due now. For most chapters, this process should take less than 15 minutes to complete. We will review this during training, should there be any concerns.

We are still waiting on DEC forms from several chapters. Please submit as soon as possible.

LVAP forms for July are due to the department within the first week of August. Please send to dolson@davma.org, they will be forwarded to National and the 2nd Jr Vice Dennis Devine. DSO and CSO please remember to also complete Mass monthly reporting form (SENA). Go to DAVMA.org, Member Portal, monthly reports to complete forms.

You will hear from me regularly to remind you of reports due and ask if you need any assistance or if you have any questions, concerns, or suggestions. The Department is here to assist the chapters we were elected or appointed to serve you. We all stand at the ready, we are an email or a phone call away. Thank you for all you do in your community. Keeping the Promise.

DAV National Convention is August 3-8th in Atlantic City, New Jersey. Our Department is happy to support DAV National 2nd Junior Vice Commander Coleman Nee for higher office. We will also support PDC Frank Whitty to join the National Executive Committee, and our Auxiliary's AnnMarie Hurley will seek higher office to DAVA National Commander! This is a great year for DAV Department of Massachusetts, and our representation at the National level couldn't be better. We are proud of each one of these candidates!

As many of you have heard, the new PACT Act expanded toxic-exposed veterans access to VA care, extended health care eligibility for Vietnam, Gulf War, and Post-9/11 era combat veterans, as well as added new presumptive conditions for radiation, Agent Orange, Gulf War toxins, and burn pit exposure.

There is no deadline to apply for PACT Act benefits, however there are upcoming timelines for retroactive benefits that will require urgent action to be eligible. If you file your PACT Act claim, or submit an intent to file by **August 9, 2023**, you may receive benefits retroactive to August 10, 2022 when the PACT Act was enacted. This is not something to wait on! If you are thinking about filing a claim, please contact a DAV Service Officer today! For a complete listing of our National, Department, and Chapter Service Officers, to include their office hours, locations, and contact information, please visit our website davma.org and click on "claims". The "locate your local office" tool at the top will direct you to the closest Service Officer in your area, and just below that is a complete listing of all our Department Service Officers, and contact information for our National Service Office team. Do not let this opportunity pass you by. Again, even filing an intent to file (saves your effective date and allows you 1 full year to formally file) will be enough to secure these benefits, but you **must** submit by August 9th!

Also on September 30, 2023 there is a deadline for some Post-9/11 veterans to enroll for VA health care under a special one-year window opened by the PACT Act. The bill automatically assumes those who served in certain locations were exposed. Once they are enrolled, veterans' individual cases will dictate what benefits they will receive. Our Service Officers will be happy to answer any questions you may have, and connect you with these benefits.

It has been a great ZipTrip season this far with Fox25 News. As we reach the half-way point in this season, we look forward to our upcoming trips to Gloucester on August 4, Whitman on August 11, Sterling on August 18, and finally Natick on August 25th! Thank you to all who have come out to support the Department at these events. 

I am looking forward to seeing many of you in Atlantic City for the National Convention this month. I know that it will be a great time as we support our National Line officers. Some would think the Summer would be a slower time but it's been crazy having to juggle staff vacations, so I can't wait for some down time; I'm sure many of you feel the same way.

As a reminder if you have not done so, please make sure you sign up for the Commander's

Action Network and support the DAV supported legislation. It's a very easy process and it truly makes a difference.

In the latest CAN support legislation: H.R. 4566 the Providing Radiation Exposed Servicemembers Undisputed Medical Eligibility (PRESUME) Act. The bill would eliminate VA's current practice of requiring radiation dose estimates for veterans claiming diseases related to radiation exposure.

Currently, VA requires not only proof of the veteran's onsite participation at a radiation risk activity, but also radiation dose estimates from the Defense Reduction Agency and a medical opinion indicating the dose estimate caused the claimed presumptive disease.

The Department of Justice (DOJ), Radiation Exposure Claims Act (RECA) program establishes compensation for individuals who contracted specified diseases related to atmospheric nuclear weapons development tests in the American southwest. The RECA program is available to uranium workers and miners, civilians exposed in down-wind areas and veterans. A lump sum is payable to veterans who were onsite participants at an atmospheric nuclear weapons test.

RECA does not require claimants to prove causation of the diseases related to the radiation exposure, nor does it require dose estimates of exposures. Veterans who were exposed onsite can receive compensation from the government without dose estimates and without proving that the claimed disease is directly caused by the dose estimate of radiation exposure.

Radiation exposed veterans are held to a higher standard by the VA, than the DOJ for civilians exposed to radiation. This unfair practice must be halted.

Unit Financial Report Form, instructions, and guidelines for completing the annual audit for the 2022-2023 filling year have been sent out by National HQ to Unit Adjutants. National HQ must receive the completed form no later than September 30, 2023.

Alternate attend the meetings only the SEC can vote.
